

J. Glenn Benedict, Esq., Chairman of the Resolution Committee, read the resolution prepared by the committee consisting of himself, John McD. Sharpe, Sr., Paul F. Mower and Blake E. Martin. The adoption of this resolution, a copy of which is attached to the minutes of this meeting and made a part hereof, was moved by Mr. Benedict, who then made some remarks about his personal friendship and professional relationship with Mr. Crider.

RESOLUTION OF FRANKLIN COUNTY BAR ASSOCIATION
ON DEATH OF PAUL M. CRIDER, ESQUIRE

Paul M. Crider passed from this life on Saturday, August 30, 1975, at the United States Veterans Hospital, Martinsburg, West Virginia. He was 80 years of age, having been born in Chambersburg, Pennsylvania, on November 2, 1894.

He graduated from Gettysburg College and thereafter entered Dickinson Law School. He interrupted his studies and enlisted in the service shortly after the United States entered World War I on April 6, 1917, serving in England and France with the American Expeditionary Forces in the Medical Corps.

After the war, he resumed the study of law at Temple University and graduated in 1921. From 1921 to 1971 he practiced law in Franklin County enjoying a large practice in real estate and in the Orphans' Court. He served both Adams County and Franklin County as State Senator from 1940 to 1948.

As a lawyer and as a Senator, he was a man of integrity and was always completely honest with his clients and with his constituents.

Franklin County Bar Association keenly feels the loss of this well-known lawyer and desires to preserve a minute thereof in testimony of the esteem in which he was held.

NOW THEREFORE, BE IT RESOLVED, that the Franklin County Bar Association this 3rd day of September, 1975, record this expression of its high regard for Paul M. Crider and for his service to this Association and to the Courts of Franklin County; and be it further
