Hour 1 of Law, Justice, and the Holocaust: How the Courts Failed Germany, 1 substantive CLE credit, Recommended for any practice area

This session explores the legal system in Nazi Germany and the role of law in the Holocaust. The program encourages discussion

about the Holocaust through the interpretation of images and case studies from the 1930s and 1940s, with special emphasis on the role played by law and jurists in the Nazi regime. Discussion will center on the persecution of targeted minorities, the ultimate loss of judicial independence in Nazi Germany during World War II, and the reign of terror imposed by the Nazi legal system from 1942-45.

<u>Presenter</u>: William F. Meinecke, Jr., Historian, United States Holocaust Memorial Museum, Levine Institute for Holocaust Education. Dr. Meinecke has been invited to share his expertise in numerous venues in both the US and abroad and has specialized in Holocaust seminars working with law enforcement officers, judges, prosecutors and attorneys on the subject of "Holocaust History and The Law."

The Supreme Court Under the Leadership of Chief Justice John Roberts, 1 substantive CLE credit, Recommended for any practice area

In June 2019, The New York Times asserted that while John Roberts had been the Chief Justice of the United States since 2005, he did not assume

"true leadership" of the Court until the 2018-2019 term. Barely three years later, a headline on CNN read: "Chief Justice John Roberts lost the Supreme Court and the defining case of his generation" (June 26, 2022). This presentation will explore Chief Justice Roberts' leadership of the Court, voting blocs, and how he will guide the institution going forward.

<u>Presenter</u>: Sara Grove, J.D., Ph.D. Sara Grove is Professor of Political Science and Chairperson of the Department of Political Science at Shippensburg University where she teaches courses on constitutional law, administrative law, and judicial process. She worked for the Governor's Office of General Counsel under Governor Ridge, as well as for the Pennsylvania Superior and Supreme Courts.

Restorative Justice: A passing fad or a meaningful way to resolve serious cases?, 1 substantive CLE credit, Recommended for Criminal Law This session will introduce to

practitioners and the bench the basic premise of restorative justice practices and will look at how one jurisdiction has been using these practices in resolving filed criminal court cases for over 10 years. Attendees will also learn what cases are best suited for a restorative justice approach and some basic guidelines to consider in designing and implementing a restorative justice option in your jurisdiction.

<u>Presenter</u>: Brett Taylor, J.D., West Coast Initiatives for the Center for Court Innovation. Brett provides technical assistance to the MacArthur Foundation's Safety and Justice Challenge Los Angeles County and Palm Beach County sites. He also works with numerous states, cities, and tribes on creating justice system strategic plans and system needs assessments. He has been the lead planner on several community courts and other projects across the country.

Unmasking the Sexual Offender, *1 substantive CLE credit*, Recommended for Family & Criminal Law

Sex offenders present difficult and complicated issues interpersonally, as well as in treatment and management. Most people do not understand why and how someone who sexually abuses does what they do, so others inaccurately apply information or explanations that do nothing more than facilitate the offenders' evasion of accountability and visibility. Denial, victim blaming, aggression, and blatant chronic deception are inherent in interactions with sexual offenders. Sex offenders, almost without fail, are not able to accept responsibility nor do they hold themselves accountable for their own behavior. Yet, they are highly effective at using biases and misinformation against others,

as well as creating a public self that hides the private one. Unfortunately, the failure to truly understand their motives and techniques helps provide excuses and further camouflage to their deviance. This training provides an overview of some of the techniques that offenders use on the victim and others to succeed in getting away with offending.

Presenter: Veronique N. Valliere, Psy.D., Valliere & Counseling Associates, Inc. and Forensic Treatment Services. Dr. Valliere is a licensed psychologist and has her doctorate in Clinical Psychology. She has over 25 years experience in the field and has worked in individual and group treatment with violent offenders and their victims, including domestic violence offenders, sexual offenders, violent offenders, and substance abusers. She also serves on the Pennsylvania Sexual Offender Assessment Board and has been reappointed since 1997.
